

26 Reasons to Investigate 9/11

1. Al Qaida created as a CIA asset to drive the Soviets from Afghanistan -- *no evidence relationship was ever dissolved*

7. with military precision, two unarmed civil airliners totaled all seven WTC buildings -- *and no others*
8. 47-story steel-framed WTC7 collapsed into its own footprint in less than 7 seconds -- *but no plane hit it*
9. Osama, fingered within hours, on the FBI's wanted list -- *but not for 9/11*
10. Afghanistan's Taliban offer to serve up Bin Laden if US showed the 9/11 attack was his -- *no follow-up by the US*
11. crime scenes in New York, Washington and Pennsylvania -- *the evidence hastily melted down in China*
12. massive abdication of defense responsibilities -- *promotions and inflated budgets awarded to those accountable*
13. Cheney/Bush administration resistance to an investigation -- *then testified collectively, unsworn and unrecorded*
14. a farcical 9/11 Report as a lengthy, cooked 'history' of Al Qaida -- *showed no forensic evidence & ignored WTC 7*
15. SEC's investigation of securities profiteering -- *abandoned because the paper trail did not lead to Al Qaida*
16. NIST's analysis of the Twin Towers' collapse -- *with controlled demolition 'off the table'*
-- *considered only the time span leading up to initiation of collapse, not during it*
-- *report on WTC7 still pending*
17. WTC leaseholder Larry Silverstein's \$\$multi-billion insurance windfall -- *from a policy tailored for acts of terrorism six weeks before the event*
18. voluminous evidence for controlled demolition found by Dr. Steven E. Jones and others -- *ignored by NIEHS, FEMA, NIST, the FAA and other government investigators*
19. alleged perpetrators -- *confessions obtained under torture without due process*
-- *wired in court to an electrocution device*
-- *CIA intentionally and illegally destroyed the interrogation videotapes*
-- *no accountability for those who destroyed the tapes*
20. White House outing of nuclear arms proliferation CIA agent Valerie Plame -- *uninvestigated and stonewalled*
-- *an act defined a priori by George H. W. Bush as the highest treason*
21. an unprovoked invasion and occupation of a sovereign nation -- *not implicated in the Attack on America*
22. a video game-style air 'war' against earthbound civilians -- *without an identifiable enemy and no end in sight*
23. careful protection of the Iraqi oil ministry -- *but crushing the Cradle of Civilization's irreplaceable artifacts into dust*
24. massive handouts to the military establishment and its vendors -- *while America's own infrastructure collapses*
25. demonization of entire societies and religions -- *with no hope for dialog with them*
26. executive branch power grab, abolishment of habeas corpus and due process -- *with 9/11 used as the rationale*
